REGISTRY FUNDS:

Interest Bearing Accounts – At the time of withdrawal 10% of the interest earned shall be paid to the General Fund of the County (Local Government Code 117.054)

Non-Interest Bearing Accounts – At the time of withdrawal a fee in an amount equal to 5% of the withdrawal but that may not exceed \$50 shall compensate the county for the accounting and administrative expenses incurred in handling the registry funds (Local Government Code 117.055)
