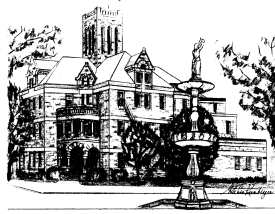

The following subjects will be discussed, considered, and acted upon:

1. Approve Claims.
2. Consider and approve Proclamation naming November 2009 as Home Care and Hospice Month in Comal County.
3. Accept recognition plaque from Comal Independent School District Board of Trustees to Commissioners Court for its excellent working relationship with and continued support of the Comal ISD.
4. Vacate and Replat of Lots 558 and 559, Mountain Springs Ranch, Unit Three, Establishing Lot 558R. (Pct. 1)
5. Final approval of Comal I.S.D. Cannan Road Subdivision; accept the dedication right-of-way within the platted road alignment and along FM 306; and grant variances. (Pct.4)

8. Review and authorize the County Judge to sign, modify, and accept the NRA Foundation grant application on behalf of Comal County Constable, Precinct 4.
9. Authorize County Judge to sign letter to the Governor's Division of Emergency Management requesting a time extension of one year, to February 8, 2011, for the construction of the Dry Comal Creek Flood Retarding Structure.

10. Confirm Comal County electoral votes cast to Eric Couch for position on Comal Appraisal District Board of Directors.
11. Consider and approve the 2010 Comal County Holiday Schedule.
12. Consider and approve rescinding Partial Release of Lien Assessment for property located at 0 Rip Jay Circle, Canyon Lake, Texas 78133, Paradise Point, Lot 22.
13. Consider and approve Corrected Partial Release of Lien Assessment for property located at 0 Rip Jay Circle, Canyon Lake, Texas 78133, Paradise Point, Lot 22.
