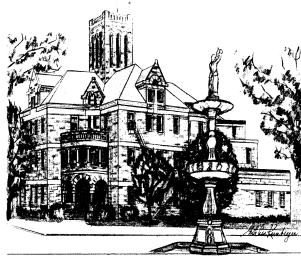

**The following subjects will be discussed, considered, and acted upon:**

1. Approve Claims.
2. Consider and approve a Proclamation Naming Detective James Leal as a Comal County Life-Saving Hero.
3. Consider and approve Resolution 2009-34 Recognizing Smithson Valley High School Softball Team.
4. Consider and approve Resolution 2009-35 Recognizing Canyon High School Softball Team.
5. Consider and approve Resolution 2009-36 Recognizing New Braunfels High School Track Team.
6. Accept donation of two (2) steel ConEx Storage Shipping Containers, valued at \$3,000.00 each, from Cemex to the Sheriff's Office, to be used for storage of equipment, supplies and evidence.
