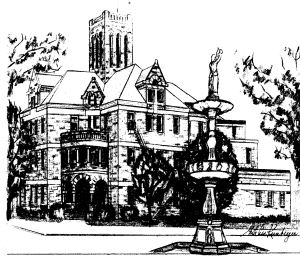

**The following subjects will be discussed, considered, and acted upon:**

1. Approve Claims.
2. Consider and approve Resolution 2009-39 Supporting Comal County Historical Commission's application to the Texas Historical Commission for Certified Local Government Grant funds to conduct a county-wide historical resources survey.
3. Accept the roads within Johnson Ranch Subdivision Phase 1, into the Comal County Unit Road System, with the exception of Horseshoe Path, Holstein Road, and Side Saddle Road. Accept dedication of public right-of-way, and release associated Paving Improvements surety, Irrevocable Letter of Credit No. 09-01. (Pct. 2)
4. Accept the roads within Gruene Haven into the Comal County Unit Road System, accept dedication of right-of-way to the public, acknowledge the completion of drainage improvements and water distribution facilities, and release associated surety, Construction Bond #6529464. (Pct. 4)
5. Consider and approve the final proposal between Comal County and Smith|Robertson for professional services to work on an Application for Endangered Species Act Section 6 "Non-Traditional" Grant on behalf of Comal County, and authorize County Judge to sign.
6. Consider and approve amended Pharmacy Consultant Agreement between Comal County Public Health and New Braunfels City Pharmacy, Inc. dba Comal Drug, and authorize County Judge to sign.
7. Consider, approve and authorize the County Judge to sign the Texas Association of Counties (TAC) Health and Benefits Pool renewal for Medical, Prescriptions, Short-term Disability, and Group Term Life rates, for Comal County employees, for 2009-2010; funding increases will be included in the 2010 Budget.
8. Consider and approve Memorandum of Agreement with Creek View Veterinary Clinic, P.C. to provide veterinary services.
9. Consider and Approve Order # 230 Granting Discretionary Exemption to Bailey's House of Guns, Inc. for the purchase of Sheriff's Office Firearms.
10. Accept statement from Purchasing Director for Sole Source Justification for captive replacement parts from Tejas Equipment for Recycling.

11. Consider and Approve Order # 231 Granting Discretionary Exemption to Tejas Equipment, Inc. for the purchase of captive replacement parts for the Bandit Beast Waste Recycler.
12. Consider and approve termination of contract with Telespan, LLP on 2008RFP08/Radio Link Replacement for Comal County Sheriff's Office for non-performance of payment bond requirement.
