

**Project Agreement By and Between
Spring Branch Tennis Association/Spring Branch Youth Football Association
and Comal County Regarding Improvements to Jumbo Evans Sports Park**

**I.
Parties**

This Project Agreement (“Agreement”) is entered into by and between Spring Branch Tennis Association/Spring Branch Youth Football Association (“SBTA/SBYFA”) and Comal County, Texas (“County”) and becomes effective upon execution by all of the parties.

**II.
Purpose**

The purpose of this Agreement is to describe the conditions for SBTA/SBYFA’s Concession Stand design project (“project”).

**III.
Agreement**

NOW, THEREFORE, for and in consideration of the premises and the mutual promises, covenants, and agreements set forth in this Agreement, the SBTA/SBYFA and the County agree as follows:

**IV.
Definitions**

Budget: The Budget (or Total Project Amount) for this project is \$22,500.

Budget Shortfall: The actual cost of a Project less the budgeted amount.

**V.
County**

1. The County will provide plans and specifications for the SBTA/SBYFA project.
2. The County will fund up to \$19,500 for the SBTA/SBYFA project.
3. The County Parks Manager will manage selected architect to prepare plans and specifications for the SBTA/SBYFA project.
4. If the SBTA/SBYFA project is cancelled before design commences, the County will refund the Entity Funding in the amount of \$3,000.

**VI.
SBTA/SBYFA**

1. SBTA/SBYFA will identify one representative that the County will coordinate with in designing the SBTA/SBYFA project.
2. SBTA/SBYFA will provide Entity Funding to Comal County in the amount of \$3,000 by August 1, 2018.
3. SBTA/SBYFA will cover any Budget Shortfalls within 30 days of notification of a Budget Shortfall. If SBTA/SBYFA cannot cover the Budget Shortfall, SBTA/SBYFA will work with County to develop a plan to design a portion of the SBTA/SBYFA project. However, in the event that the County deems the project unfeasible or if a portion of the project cannot be constructed, the SBTA/SBYFA project will be cancelled.

**VII.
Term**

This Agreement shall begin on the date of the last signature and shall remain in force and effect until the SBTA/SBYFA design project is completed or cancelled.

**VIII.
Notice**

The designated representatives of the Parties shall be the following, who shall be fully authorized by their respective entities to receive notification required under this Agreement and to take any action

delegated to a designated representative under this Agreement. All notices required under this Agreement shall be given by regular mail or certified mail addressed as follows:

IX.

Law and Venue

This Agreement shall be construed and enforceable in accordance with the laws of the State of Texas. Exclusive venue shall be in a court of competent jurisdiction in Comal County, Texas.

X.

Immunity

No provision of this agreement shall affect or waive any sovereign or governmental immunity available to the County and/or its elected officials, officers, employees and agents under Federal or Texas law nor waive any defenses or remedies at law available to the County and/or its elected officials, officers, employees and agents under Federal or Texas law.

XI.

Entire Agreement

This Agreement contains the entire agreement between the parties and correctly sets forth the rights, duties and obligations of each to the other as of the Effective Date. Any oral representations or modifications concerning this Agreement will be of no force or effect excepting a subsequent written modification executed by both parties

XII.

Execution

The County executes this Agreement by and through the County Judge acting under the authorization of the Commissioners Court of Comal County, Texas. SBTA/SBYFA executes this Agreement under the authorization of the SBTA and SBYFA Boards. This agreement shall not become effective until executed by all parties.

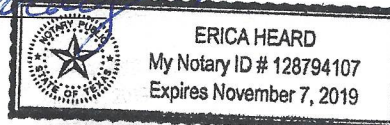
