RESOLUTION NO. 2019-11

**IN THE MATTER OF THE COMMISSIONERS COURT OF COMAL COUNTY, TEXAS
RECOMMENDING PROJECTS TO THE ALAMO AREA METROPOLITAN
PLANNING ORGANIZATION FOR UNFUNDED PROJECTS FOR THE 2050
METROPOLITAN TRANSPORTATION PLAN UPDATE WITHIN
COMAL COUNTY**

WHEREAS, Comal County, Texas, is a member of the Alamo Area Metropolitan Planning Organization (the "AAMPO"); and

WHEREAS, the AAMPO has requested a list of unfunded projects to be included in its 2050 Metropolitan Transportation Plan ("MTP") update; and

WHEREAS, the MTP is used as a forecasting tool for analysis of the regional transportation needs over the next 25 years; and

WHEREAS, representatives from Comal County, Guadalupe County, the City of New Braunfels and the City of Seguin met and discussed the transportation needs for the region; and

WHEREAS, the representatives from the above four local governments developed a list of recommended projects to be submitted to AAMPO for inclusion into the 2050 MTP update; and

WHEREAS, Comal County wishes to submit additional projects within the unincorporated area of Comal County.

NOW, THEREFORE, BE IT RESOLVED that the Commissioners Court of Comal County, Texas, hereby recommends the roadway improvement projects as indicated in the two sections below:

SECTION 1. Representatives from Comal County, Guadalupe County, the City of New Braunfels, and the City of Seguin have identified the following projects within the two county region to be submitted to AAMPO for inclusion into the 2050 MTP update:

1. SH 46
 - a) Direct connectors at the intersection of IH35.
 - b) Direct connectors at the intersection of IH10.
 - c) Added capacity – 4 lane divided with left and right turn lanes as required.
2. FM 758
 - a) Added capacity – 4 lane divided with left and right turn lanes as required. New Guadalupe River bridge.

SECTION 2. Comal County projects within the unincorporated area of the County that are recommended to be included into the AAMPO 2050 MTP update:

1. SH 46
 - a) Intersection improvements at FM 3009, FM 311, and S. Cranes Mill Rd.

2. FM 306
 - a) Improve between TxDOT Roadside Park and Cannan Rd to 4 lanes with left/right turn lanes and signalization at all major roadway intersections.

3. SH 46
 - a) Improve between Bulverde Rd. and the Comal/Kendall County line to a divided 4-6 lane roadway with left/right turn lanes and signalization at all major roadway intersections.
 - b) Improve between Range Rd. and FM 3159 to a divided 4-6 lane roadway with left/right turn lanes and signalization at all major roadway intersections.

4. FM 1863
 - a) Improve between US281 and the Smithson Valley Road to a divided 4-lane roadway with left/right turn lanes and signalization at all major roadway intersections.

5. FM 3009
 - a) Provide improved shoulders.

6. NW Connector (new alignment)
 - a) 4 lane divided highway connecting SH46 @ Resource Dr. to IH35 @ Schwab Rd.

7. Blanco Road
 - a) Added capacity – 4 lane divided with left and right turn lanes as required from the Bexar/Comal County line to SH46.

NOW, THEREFORE, BE IT FURTHER RESOLVED, the Comal County Commissioners Court hereby submits this recommendation to the Alamo Area Metropolitan Planning Organization for their consideration.
