A RESOLUTION BY THE COMMISSIONERS COURT OF COMAL COUNTY, TEXAS AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION UNDER THE SPECIALTY COURTS GRANT PROGRAM THROUGH THE OFFICE OF THE GOVERNOR IN THE AMOUNT OF \$72,833.34, TO SUPPORT THE INCREASING ACCOUNTABILITY PROGRAM

WHEREAS, the Commissioners Court of Comal County finds it in the best interest of the citizen's of Comal County, Texas, that the Increasing Accountability Program be operated for the 2019 Grant Year through the Office of the Adult Probation; and

WHEREAS, the Commissioners Court of Comal County understands the project period of performance will be from date of acceptance to October 31, 2019; and

WHEREAS, the Commissioners Court of Comal County understands that of the total project cost of \$72,833.34, 100 percent will be reimbursed with no match requirement; and

WHEREAS, the Commissioners Court of Comal County agrees that in the event of loss or misuse of the Office of the Governor funds, the Commissioners Court of Comal County assures that the funds will be returned to the Office of the Governor in full; and

WHEREAS, the Commissioners Court of Comal County designates County Judge Sherman Krause as the grantee's authorized official. The authorized official is given the power to apply for, accept, reject, alter or terminate the grant on behalf of the applicant agency.

NOW THEREFORE BE IT RESOLVED that the Commissioners Court of Comal County approves the submission and acceptance of the grant award for the FY19 Specialty Court Grant Program to the Office of the Governor.
