All nominations are submitted to the Office of Commissioner Parker. Nomination shall be submitted after February 1st but not later than March 6th 2009. A selection board will select one recipient from each category. The awards will be presented at the annual Child Abuse Prevention Month Kick-off Event scheduled for April 3, 2009.

Nomination packets must include at a minimum:

2009 Guardian Angel Award Categories

Guardian Angel Volunteer of the Year Award - One Outstanding Volunteer of the Year will be selected for outstanding service within the non-profit agencies for the year 2009.

Requirements and justification should reflect:

- At least 6 months or more volunteer (non-paid) work with a non-profit agency that provides services in accordance to Section 51.961 of the Texas Government Code.
- Positive communication with the community and victims.
- A range and depth of participation and or support for child abuse and family violence prevention activities.

Guardian Angel Agency Member of the Year Award - One Agency Member of the Year will be selected for outstanding service within law enforcement, the District Attorney's Office and or Child Protective Services agencies, for the year 2009.

Justification should reflect:

- At least 1 year or more work (non-paid or paid) within the law enforcement, District Attorney's Office and or Child Protective Services agencies.
- Positive communication with the community and victims.
- A range and depth of participation and or support for child abuse and family violence prevention activities.

Guardian Angel Longevity Award - One Longevity Award will be selected for sustained outstanding service to fighting child abuse and family violence.

Justification should reflect:

- At least 8 years or more (volunteer non-paid or paid) work with a non-profit agency that provides services in accordance to Section 51.961 of the Texas Government Code and or work within law enforcement, the District Attorney's Office and or Child Protective Services agencies.
- Positive communication with the community and victims.
- A range and depth of participation and or support for child abuse and family violence prevention activities.
