Proclamation

Recognizing October 2018 as

Domestic Violence Awareness Month in Comal County

WHEREAS, the first Domestic Violence Month was observed in October 1987, the same year that saw the initiation of the first national domestic violence toll-free hotline; and

WHEREAS, in 1989 Congress designated October as National Domestic Violence Awareness Month; and

WHEREAS, domestic violence is a pattern of assaultive and coercive behaviors – including physical, psychological, sexual and economic abuse; social isolation; and stalking – that are used to maintain power and control over a person’s intimate partner; and

WHEREAS, the crime of domestic violence violates an individual’s dignity, safety and basic human rights; and

WHEREAS, domestic violence is the single largest cause of injury and homicide for women; and

WHEREAS, children exposed to domestic violence experience terror, isolation, guilt, helplessness and grief, and have a higher risk of engaging in criminal behavior and substance abuse, and becoming victims of crime; and

WHEREAS, domestic violence crosses all ethnic, racial, sexual preference, economic, age, educational, and religious lines; and

WHEREAS, in the last fiscal year, the Crisis Center of Comal County helped more than 1,174 clients and provided 15,359 nights of shelter to victims and survivors of domestic violence; and

WHEREAS, it is incumbent on every citizen to assist those suffering from domestic abuse and let victims know that support is available; and

WHEREAS, the Crisis Center of Comal County, New Braunfels Police Department, Comal County Sheriff’s Office, Comal County District Attorney’s Office and the medical community are working together to develop solutions to this serious social problem and implement effective services that will improve our responses and put an end to domestic violence.

NOW, THEREFORE, BE IT PROCLAIMED that the Comal County Commissioners Court, duly convened and acting in its capacity as the governing body of Comal County, proclaims the month of October 2018 as Domestic Violence Awareness Month in Comal County.
