Award of a Contract will be to the lowest, responsible bidder meeting all requirements of the Bid Documents.

Remove and replace Time of Completion on page 2 with:

TIME OF COMPLETION: The undersigned bidder agrees to commence work within ten (10) Calendar Days after written notice as specified in a written "Notice to Proceed" to be issued by the OWNER and to **finally** complete construction of the improvements, as required by the Bid Documents, Drawings and Addenda for the Work within ninety (90) **Calendar** Days after the date of the written "Notice to Proceed." The bidder further agrees that should the bidder fail to **finally** complete the Work within the number of days indicated in the Bid or as subsequently adjusted, bidder shall pay the liquidated damages for each consecutive day thereafter as provided below; unless the OWNER elects to pursue any other action allowed by law.

Remove and replace Agreement page with Agreement page included in this addendum.

5. Section 700 - Technical Specifications & Drawings

Remove and replace Technical Specifications & Drawings 1-8 with Technical Specifications & Drawings 1-7 included in this addendum.
