Previously stating: "Signed original letter of good standing, dated within 90 days prior to the filing of this application, from the bail bond board or bonding authority of each Texas county in which the applicant has ever been licensed."

Section 1704.154 Texas Occupations Code Reads:

(G) "If the applicant is or has been licensed under this Chapter in another county, [the applicant shall provide] (1) a list of each county in which the applicant holds a license; and (2) a statement by the applicant, as of the date of the application, of any final judgments that have been unpaid for more than 30 days and that arose directly or indirectly from a bail bond executed by the applicant as a surety or as an agent for a surety.

(H) If the applicant is a corporation, a statement by the designated agent, as of the date of the application, of any final judgments that have been unpaid for more than 30 days and that arose directly or indirectly from any bond executed by the agent as a surety or as an agent for a surety. "
