A RESOLUTION BY THE COMMISSIONERS COURT OF COMAL COUNTY, TEXAS AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION UNDER THE 2020 HELP AMERICA VOTE ACT (HAVA), CARES ACT SUB-GRANT THROUGH THE TEXAS SECRETARY OF STATE IN THE AMOUNT OF \$151,140.85, TO PREVENT, PREPARE FOR AND RESPOND TO CORONAVIRUS FOR THE 2020 FEDERAL ELECTION CYCLE.

WHEREAS, the Commissioners Court of Comal County agrees that the expenditure of the funds will be in accordance with applicable federal and state law and any agreement between Comal County and the State of Texas, Office of the Secretary of State as authorized under Section 101 of the Help America Vote Act of 2002 and in consultation and agreement with the county election official(s) as defined in Sections 12.001 and 31.091 of the Texas Election Code; and

WHEREAS, the Commissioners Court of Comal County agrees to assign a single point of contact (SPOC) to act on behalf of the county in communicating with the Office of the Secretary of State, including the submission of all necessary reports; and

WHEREAS, the Commissioners Court of Comal County agrees claims against the fund shall be audited and approved in the same manner as other claims against the county before they are paid; and

WHEREAS, the Commissioners Court of Comal County agrees that it will not consider the availability of the funds in adopting the county budget; and

WHEREAS, the Commissioners Court of Comal County agrees that in the event of loss, misuse, or noncompliance pursuant to any grant award agreement with the Secretary of State, the Commissioners Court of Comal County assures that the funds will be returned to the Office of the Secretary of State in full.

NOW THEREFORE BE IT RESOLVED that the Commissioners Court of Comal County approves submission of the 2020 Help America Vote Act (HAVA) CARES Act Sub-Grant to the Office of the Secretary of State.
