

**MINUTES OF A MEETING OF THE
COMMISSIONERS COURT OF COMAL COUNTY, TEXAS**


On this, the 9th day of November, 2021, at 8:30 o'clock A.M., the Commissioners Court met in a properly called and posted public session, pursuant to statutory notice and call, and after having given and posted the required public notice for more than seventy-two (72) hours prior to said meeting, as required by the Texas Open Meeting Law, for the announced purpose of adopting a resolution pertaining to the redistricting of the Commissioners and the Justice of the Peace Precincts.

WHEREAS, upon motion duly made and seconded, a RESOLUTION ADOPTING THE PLAN TO REDISTRIBUTE AND REDEFINE THE COMMISSIONERS AND JUSTICE PRECINCTS was passed and adopted.

This redistricting will become formally effective on January 3, 2022 and will be used as the basis for conducting future elections.

Announcements were made as required by law, and upon motion duly made and seconded, the Resolution unanimously passed.

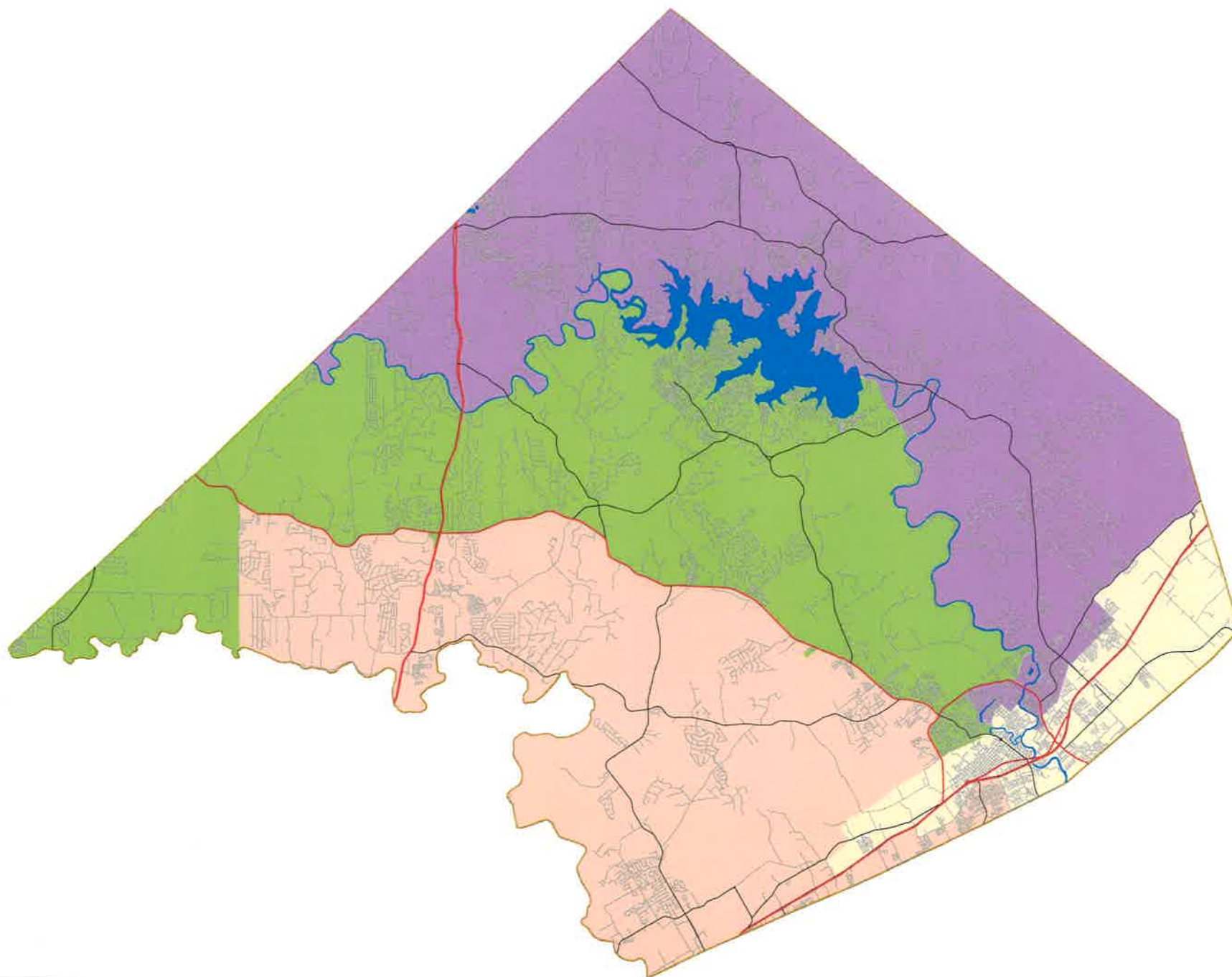

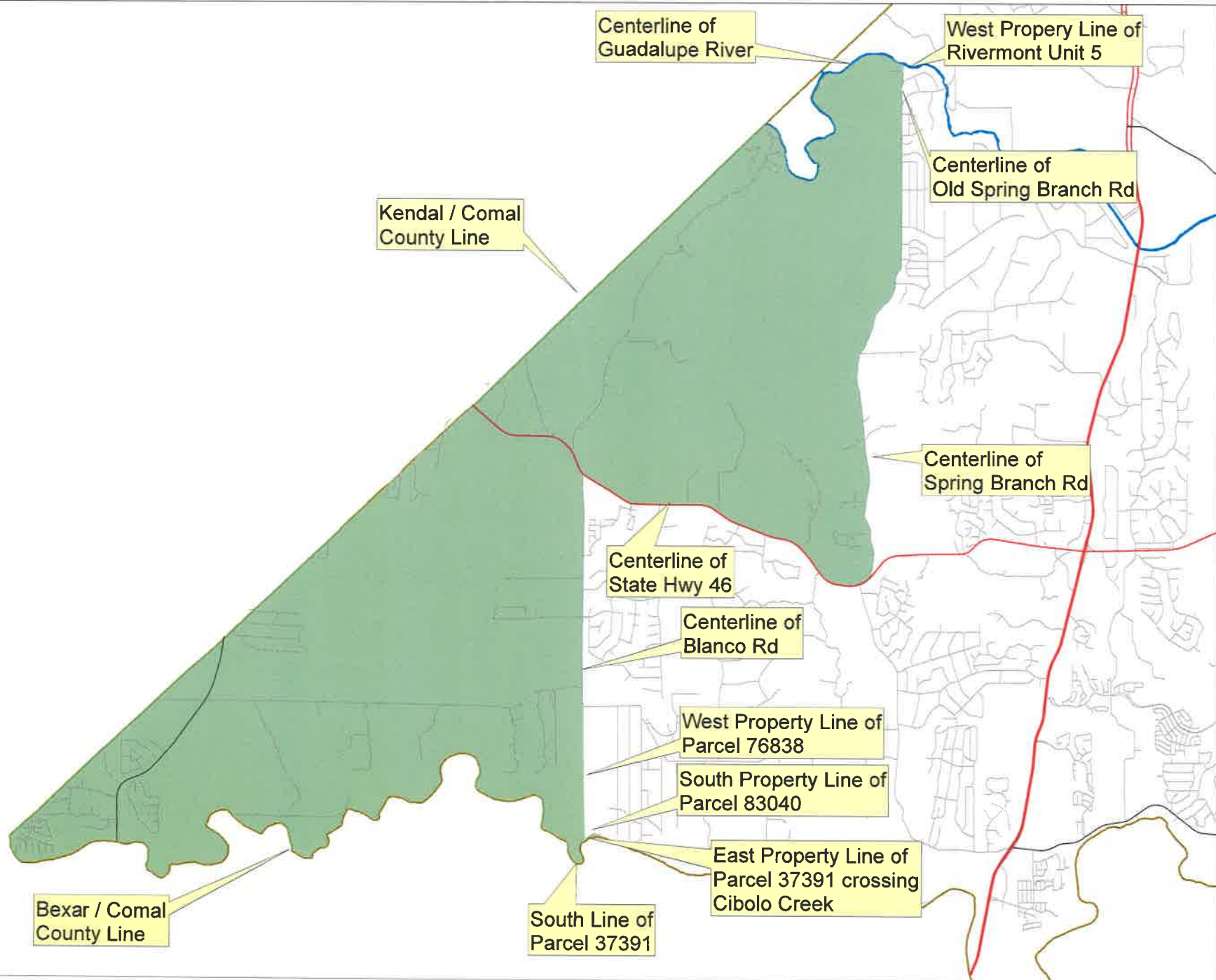
