**TERMINATING LOCAL STATE OF DISASTER AND RESCINDING ORDER # 494
CONTINUATION OF DECLARATION OF LOCAL DISASTER FOR COMAL
COUNTY, TEXAS**

WHEREAS, on August 11, 2023, the County Judge, pursuant to the Texas Government Code, Chapter 418, (the "Texas Disaster Act"), issued a Declaration of Local Disaster for the Comal County, Texas, resulting from inadequate rainfall for an extended period with ongoing hot, dry conditions that pose a threat of large, dangerous, and fast-moving wildfires, which constitute a potential and imminent threat of disaster and damage to lives and property; and

WHEREAS, on August 17, 2023, the Commissioners Court of Comal County approved Order # 494 for Continuation of Declaration of Local Disaster for Comal County, Texas, due to the extremely dry weather conditions and threat of wildfires and ordered that this state of local disaster continue until rescinded in accordance with Chapter 418 of the Texas Local Government Code; and

WHEREAS, recent rainfall in the months of September 2023 and October 2023 has helped alleviate the hot, dry conditions that posed a threat of wildfires; and

WHEREAS, the conditions necessitating the Declaration of Local Disaster for the Comal County, Texas, and Order # 494 have ceased to exist; and

WHEREAS, Section 418.108(c) of the Texas Local Government Code provides that a local state of disaster may be terminated.

NOW THEREFORE, the Commissioners Court of Comal County, Texas, duly convened and acting in its authority as the governing body of Comal County, Texas, hereby orders that the Declaration of Local Disaster for the Comal County, Texas, and Order # 494 Continuation of Declaration of Local Disaster for Comal County, Texas, described in the preamble above are terminated.

FURTHERMORE, this Order #506 shall take effect immediately upon its approval by the Commissioners Court of Comal County, Texas and shall be given prompt and general publicity and shall be promptly filed with the County Clerk.
