Comal County reports 22 additional COVID-19 cases; TSA P drops below 6%

FOR IMMEDIATE RELEASE: March 10, 2021:

NEW BRAUNFELS — Comal County is reporting 22 additional cases of COVID-19. Total cases for the County is now 9,368. Seven are confirmed cases and 15 are probable cases. Three of the 22 reported cases are backlogged cases being added to data. The total number of deceased remains at 298.

The County has 387 active confirmed and probable COVID-19 cases.
 Of those, 48 are hospitalized.
 There are 46 COVID-19 recoveries to report today.
 The total recovered is 8,683.

On Wednesday, Comal County hospitals reported caring for 16 COVID-19 patients; of those, seven are in intensive care and seven are on ventilators. Not all of these patients are necessarily county residents; likewise, not all county residents hospitalized with COVID-19 are in Comal County hospitals.

TSA P percentage today is 5.82%.

As of Wednesday morning, Public Health has received reports of the following test information:

- 66,174 tests conducted
- 4,937 confirmed cases
- 4,411 probable cases
- 20 suspect cases.

**The seven-day Molecular positivity rate for Wednesday in Comal County is 80.62%.
The seven-day Antigen positivity rate for Wednesday in Comal County is 14.8%.**

Of the 9,368 confirmed and probable COVID-19 cases in Comal County, the location breakdown is:

Vaccines will be distributed to the public as they are received by Comal County and according to all state distribution guidelines.

Probable case definition

“Probable case” is a category established by the Texas Department of State Health Services to describe those who do not have a positive PCR test for COVID-19 but meet two of the following three criteria:

- Meets clinical criteria AND epidemiologic linkage with no confirmatory laboratory testing performed for SARS-CoV-2.
- Meets presumptive* laboratory evidence.
 - Presumptive* laboratory evidence:
 - Detection of SARS-CoV-2 by antigen test in a respiratory specimen
- Meets vital records criteria with no confirmatory laboratory evidence for SARS-CoV-2.

A probable case is treated identically to a confirmed case and counts toward the County’s positivity rate and total case tally.

Suspect case definition

A “Suspect case” meets supportive laboratory evidence with no prior history of being a confirmed or probable case. It is also counted towards the total case tally.

Supportive Laboratory Evidence means:

- **Detection of specific antibody in serum, plasma, or whole blood**
- **Detection of specific antigen by immunocytochemistry in an autopsy specimen.**
