### Comal County reports 39 additional COVID-19 cases

**FOR IMMEDIATE RELEASE: March 12, 2021:**

*NEW BRAUNFELS* — Comal County is reporting 39 additional cases of COVID-19. Total cases for the County is now 9,419. 17 are new cases and 22 are backlogged cases being added to County data. 12 are confirmed cases and 27 are probable cases. The total number of deceased remains at 298.

The County has 325 active confirmed and probable COVID-19 cases. Of those, 44 are hospitalized. There are 65 COVID-19 recoveries to report today. The total recovered is 8,796.

On Friday, Comal County hospitals reported caring for 14 COVID-19 patients; of those, six are in intensive care and five are on ventilators. Not all of these patients are necessarily county residents; likewise, not all county residents hospitalized with COVID-19 are in Comal County hospitals.

**TSA P percentage today is 5.18%.**

As of Friday morning, Public Health has received reports of the following test information:

- 66,549 tests conducted
- 4,955 confirmed cases
- 4,443 probable cases
- 21 suspect cases.

**The seven-day Molecular positivity rate for Friday in Comal County is 75.83%.  
The seven-day Antigen positivity rate for Friday in Comal County is 10.75%.**

Vaccines will be distributed to the public as they are received by Comal County and according to all state distribution guidelines.

#### **Probable case definition**

“Probable case” is a category established by the Texas Department of State Health Services to describe those who do not have a positive PCR test for COVID-19 but meet two of the following three criteria:

- Meets clinical criteria AND epidemiologic linkage with no confirmatory laboratory testing performed for SARS-CoV-2.
- Meets presumptive\* laboratory evidence.
  - Presumptive\* laboratory evidence:
    - Detection of SARS-CoV-2 by antigen test in a respiratory specimen
- Meets vital records criteria with no confirmatory laboratory evidence for SARS-CoV-2.

A probable case is treated identically to a confirmed case and counts toward the County’s positivity rate and total case tally.

#### **Suspect case definition**

A “Suspect case” meets supportive laboratory evidence with no prior history of being a confirmed or probable case. It is also counted towards the total case tally.

#### **Supportive Laboratory Evidence means:**

- **Detection of specific antibody in serum, plasma, or whole blood**
- **Detection of specific antigen by immunocytochemistry in an autopsy specimen.**
