### Comal County reports 11 new COVID-19 cases

**FOR IMMEDIATE RELEASE: March 29, 2021:**

*NEW BRAUNFELS* — Comal County is reporting 11 new COVID-19 cases today. Total cases for the County is now 9,654. Five are confirmed cases and six are probable cases. The total number of deceased remains at 305.

Comal County has 177 active confirmed and probable COVID-19 cases. Of those, five are hospitalized. There are another 13 COVID-19 recoveries to report today. The total recovered is 9,172.

On Monday, Comal County hospitals reported caring for nine COVID-19 patients; of those, two are in intensive care and two are on ventilators. Not all of these patients are necessarily county residents; likewise, not all county residents hospitalized with COVID-19 are in Comal County hospitals.

**TSA P percentage today is 3.67%.**

As of Monday morning, Public Health has received reports of the following test information:

- 71,680 tests conducted
- 5,076 confirmed cases
- 4,557 probable cases
- 21 suspect cases

**The seven-day Molecular positivity rate for Monday in Comal County is 4.41%.**

**The seven-day Antigen positivity rate for Monday in Comal County is 2.74%.**

Of the 9,654 confirmed and probable COVID-19 cases in Comal County, the location breakdown is:

**Beginning today, Monday, March 29, the Vaccine Standby List is open to all adults. Comal County Health Department administers the Moderna Vaccine, which can be used for those 18 years of age and older.**

**Registering online is the best option for residents because phone resources are limited.**

**Those who do not have computer access or need assistance can call 830.620.5575.**

Vaccines will be distributed to the public as they are received by Comal County and according to all state distribution guidelines.

#### **Probable case definition**

“Probable case” is a category established by the Texas Department of State Health Services to describe those who do not have a positive PCR test for COVID-19 but meet two of the following three criteria:

- Meets clinical criteria AND epidemiologic linkage with no confirmatory laboratory testing performed for SARS-CoV-2.
- Meets presumptive\* laboratory evidence.
  - Presumptive\* laboratory evidence:
    - Detection of SARS-CoV-2 by antigen test in a respiratory specimen
- Meets vital records criteria with no confirmatory laboratory evidence for SARS-CoV-2.

A probable case is treated identically to a confirmed case and counts toward the County’s positivity rate and total case tally.

#### **Suspect case definition**

A “Suspect case” meets supportive laboratory evidence with no prior history of being a confirmed or probable case. It is also counted towards the total case tally.

**Supportive Laboratory Evidence means:**

- **Detection of specific antibody in serum, plasma, or whole blood**
- **Detection of specific antigen by immunocytochemistry in an autopsy specimen.**
