Comal County reports 25 new COVID-19 cases; Another 10 backlogged cases added to County data

FOR IMMEDIATE RELEASE: April 14, 2021:

NEW BRAUNFELS — Comal County is reporting 25 new COVID-19 cases. 10 backlogged cases will be added to County data.

Total cases for the County is now 9,942.

17 are confirmed cases, 16 are probable cases and two are suspect cases.

Comal County now has 219 active confirmed and probable COVID-19 cases.

Of those, 12 are hospitalized.

There are another 26 COVID-19 recoveries to report today.

The total recovered is 9,411.

On Wednesday, Comal County hospitals reported caring for 13 COVID-19 patients; of those, four are in intensive care and three are on ventilators. Not all of these patients are necessarily county residents; likewise, not all county residents hospitalized with COVID-19 are in Comal County hospitals.

Today's TSA P percentage is 3.96%

As of Wednesday morning, Public Health has received reports of the following test information:

- 76,209 tests conducted
- 5,258 confirmed cases
- 4,661 probable cases
- 23 suspect cases

The seven-day Molecular positivity rate for Wednesday in Comal County is 9.69%.

The seven-day Antigen positivity rate for Wednesday in Comal County is 5.57%.

Of the 9,942 confirmed and probable COVID-19 cases in Comal County, the location breakdown is:

The Comal County COVID-19 Vaccine Standby List is open to adults 18 and older.

Residents interested in receiving a COVID-19 vaccine can visit www.co.comal.tx.us to register.

The Comal County Health Department administers the Moderna Vaccine, which is used for those 18 years of age and older.

Registering online is the best option for residents because phone resources are limited.

Those who do not have computer access or need assistance can call 830.620.5575.

Vaccines will be distributed to the public as they are received by Comal County and according to all state distribution guidelines.

Probable case definition

“Probable case” is a category established by the Texas Department of State Health Services to describe those who do not have a positive PCR test for COVID-19 but meet two of the following three criteria:

- Meets clinical criteria AND epidemiologic linkage with no confirmatory laboratory testing performed for SARS-CoV-2.
- Meets presumptive* laboratory evidence.
 - Presumptive* laboratory evidence:
 - Detection of SARS-CoV-2 by antigen test in a respiratory specimen
- Meets vital records criteria with no confirmatory laboratory evidence for SARS-CoV-2.

A probable case is treated identically to a confirmed case and counts toward the County’s positivity rate and total case tally.

Suspect case definition

A “Suspect case” meets supportive laboratory evidence with no prior history of being a confirmed or probable case. It is also counted towards the total case tally.

Supportive Laboratory Evidence means:

- **Detection of specific antibody in serum, plasma, or whole blood**
- **Detection of specific antigen by immunocytochemistry in an autopsy specimen.**
