Proclamation

Recognizing the Greater New Braunfels Chamber of Commerce in Celebration of Its Centennial Birthday

WHEREAS, on April 9, 1919, New Braunfels business leaders convened a meeting to organize a Chamber of Commerce to promote the commercial resources of the city and to advocate advanced methods in municipal affairs; and

WHEREAS, on April 9, 2019, the Greater New Braunfels Chamber of Commerce will celebrate its centennial birthday, marking 100 years of ensuring Success Flows Here; and

WHEREAS, in its history, not a single year has passed where the Greater New Braunfels Chamber of Commerce has not influenced the growth and quality of life of this unique community through significant accomplishments with long-lasting benefits to the prosperity of New Braunfels; and

WHEREAS, the Chamber has been successful in education, advocacy and municipal affairs, including the creation of the Central Texas Technology Center, directing the Texas Legislative Conference for 53 years, and securing both the City Charter and a council-manager form of government; and

WHEREAS, the Chamber has also advanced the region's transportation, economic development and tourism – helping obtain \$100 million for widening Interstate 35, establishing the Greater New Braunfels Economic Development Foundation and attracting tens of thousands of jobs to the community, supporting and promoting Wurstfest, successfully advocating for tourism-promotion funds, and bringing tens of millions of visitors with money to spend in New Braunfels; and

WHEREAS, the Chamber has also been successful in preserving natural resources while advancing small business services, and expanding leadership development – including advocating for the development of Canyon Dam, creating the Water Oriented Recreation District, creating and supporting the Small Business Development Center, presenting the Business Trade Show for 31 years, supporting the New Braunfels Jaycees since its inception in 1934, and graduating more than 1,200 participants from the adult and youth Leadership New Braunfels programs; and

WHEREAS, with a century of achievement behind it, the Greater New Braunfels Chamber of Commerce is looking forward with a continued commitment to ensuring a vibrant and prosperous community for future generations.
